Montessori International Academy had communication and meetings with Parents/ Parents Support Community (7/25, 8/4,11,18, 25). Survey on July 10 and August 6th. 70.6% in coming and 29.4% remote. 95% want to come back slowly with safety plan called MIACARE (7 feet distance etc..)

If no labor organization represents staff at the school, please describe the process for consultation with school staff:

Teachers and Staff have meetings weekly to discuss reopening plan. We have remote education started on March 23. Teachers want to continue having our parents to have choice with remote education while we are carefully getting children back to in person learning. Staff survey 95% wants to support in-person teaching but gradual process. One teacher wants to work from home, MIA will accommodate the work for the teacher.
